# 3. Fees and Payment Terms

- 3.1 The Client agrees to pay the Service Provider a fee as per the chosen service package or customized agreement. A detailed breakdown of fees is provided in **Schedule A** attached hereto.
- 3.2 Payments shall be made as follows:
  - 100% advance payment upon signing this Agreement.
  - Remaining balance upon completion of specified milestones.
